### List of criteria for additional financial support for Erasmus students with fewer opportunities in the funding year 2022/23

The top-ups cannot be combined with each other. (i.e.: two top-ups are not paid for employed students who are first-time graduates), but can be combined with the top-ups for internships and green travel.

The top-ups for disabled persons, chronically ill people and students with children are obligatory, the top-ups for employed students and first-time graduates are optional. The TU Hamburg reserves the right to make a payment depending on the approved total funding amount.

- A degree from a Berufsakademie leading to a qualification comparable to a university degree is to be regarded as an academic degree. A master craftsman's diploma ("Meisterbrief") is not to be equated with an academic degree in this context.
- Courses of study completed abroad by one of the parents that are not recognised as such in Germany (e.g. physiotherapy) are deemed to be academic degrees within the framework of the eligibility criteria for receiving the supplementary grant, so there is no entitlement to the supplementary grant.

#### **Possible Proof**

- Medical certificate confirming that additional financial requirements will arise abroad due to the chronic illness in question
- The type of illness and the amount/scope of the additional need do not have to be noted or quantified.

In addition, students with disabilities or chronic illnesses can apply for the reimbursement of real costs of up to 15,000 euros by submitting a so-called long term application with significantly higher costs. Proof of the exact costs is required.
